Booking & Payment

ChileMontaña program has a booking deadline and please keep in mind that some of our programs require a mandatory medical certificate. We will confirm your booking request once we have received a 10% deposit (non-refundable) of the total cost of the program. The balance is due 30 days, 60 days if trip occurs during high season (October 20th to January 10th), prior to the program's start date. Please note that our trips and expeditions to Patagonia and our ski programs have a slightly different payment scheme. You will be given the payment details for these programs when booking.

All prices are based on double accommodation. Participants who desire single accommodation should request this arrangement in advance. If single accommodation is available, participants will pay a single supplement, which varies by accommodations and locations. In regards to set departures, if the minimum number of participants required is not reached, ChileMontaña will cancel the departure, subject to 60 days notice, and a full refund will be offered. Alternatively we offer the possibility that additional costs will be carried by those clients who have already booked the trip. Every reasonable effort will be made by ChileMontaña to ensure that all clients' trip objectives are met.

Cancellations

Clients may cancel their trip at any time provided that the cancellation is sent to ChileMontaña in written form. The following penalties will be applied to cover administration costs:

- If cancellation occurs within 16 to 29 (16 to 59 in high season) days prior to the start of the trip, 50% of the program is non-refundable.
- If cancellation occurs less than 15 day prior to the start of the trip, no refund will be given.

In case of cancellation, ChileMontaña will notify the client as soon as possible and will offer the client the possibility to change his/her booking to an alternative program. If the client declines this possibility, any money received by ChileMontaña from the client for that program or expedition will be refunded, and the limit for this refund will be the limit of ChileMontaña liability. ChileMontaña is not responsible for any expenses incurred by the client in preparing for the trip, including non-refundable or penalty-carrying airline tickets.

ChileMontaña strongly recommends that you purchase a trip cancellation and/or interruption insurance. Such a policy will offset cancellation charges in the event of illness before or during the trip.

Responsibilities

ChileMontaña reserves the right to change or withdraw any travel arrangements when deemed necessary or in the best interests of our clients. This is especially applicable when faced with unforeseen weather conditions that prevent us from running a trip safely. We reserve the right to refuse service to any passenger should he/she jeopardizes group safety or engages in illegal, abusive, or offensive behaviour. No refunds will be given in these cases. Luggage travels at the owner's risk throughout the tour, although we take all necessary precautions. We are not responsible for cancellation of any services due to natural disasters, social upheavals or other circumstances out of our control. Participants have the responsibility to select a trip appropriate to their abilities and interests. In order to assist you, required effort is listed for each trip. We are also happy to discuss the details of trips and activities with you.

Trip members are held responsible for being in sufficient health to undertake the trip. Trip members are responsible for preparing for the trip by studying the itinerary and pre-departure information sent by ChileMontaña and for bringing the appropriate clothing and equipment as advised therein.

ChileMontaña is not responsible for any expenses incurred nor is obligated to lend money to pay for emergency expenses in case participants require a rescue or evacuation or the participant leaves the trip before it's end for any reason whatsoever. Therefore, **ChileMontaña strongly recommends that clients take out an adequate insurance policy.** If clients do not take insurance, ChileMontaña can, at the clients' expense, arrange for medical treatment or an emergency evacuation if it is deemed essential for the clients' safety.

Inclusions & Exclusions

Meals: Meals provided are specified on itineraries as breakfast (B), lunch (L), picnic lunch (PC), and dinner (D). Spring water, soft drinks, and juices are included with all meals, but alcohol is not included unless specified. Some trips do not include full meals, but you may request them at an additional cost. Airfare: The prices of our trips DO NOT include airfare unless specified. We are happy to reserve and sell the necessary airline tickets for your arrival and departure. Prices vary according to season. Airport transfers: International and domestic airport transfers are not included unless specified. Entrance fees: Our trips DO NOT include entrance fees to national parks, reserves, or protected areas, unless specified. Guides and transportation: All activities specified in itineraries are guided. Our trips include all necessary land transportation in safe, private, quality 4x4 vehicles, vans, and/or buses.
